Esteemed delegates of the Conference,

Junta gave its final response to the debate continuing discussions in the national and international public opinion. Esteemed delegates,

If this constitution come into force, it will be impossible to mention about democracy, fundamental freedoms and human rights in our country. The constitution of Junta abolishes political rights, trade union freedoms, and fundamental economic and social rights. I will approach to the question regarding the workers and union rights.

Junta aims the spearhead of its attack with this constitution to the working class and union movement of Turkey.

- With its all power abolishes the union rights and freedoms.
- It banns political activity to the unions.
- It restrics the right to form unions. It was closes all the doors for young workers to form unions.
- In essance it abolishes the right to conclude collec-

tive Wayyon agreements and right to strike. It banns general strike, solidarity and symphaty strikes and strikes for un-fulfilled agreements.

- It empowers the administrative authorities to postone strik without a cour order.
- Unions are brought under the control of state and administrative authorities appeared and intervention.
- International relations of the unions are restricted and in some instances totally abolisched.
- It covers provisions to force the workers leave the unions.

In short the union rights and freedoms are abolished as a whole.

Esteemed delegates,

It is impossible to forget the contributions of the administration of TÜRK-İŞ in the process of two year long breaching of the union rights and freedoms and today's last attack to abolish them complately.

The highest administration of TURK Is and the the 12th of September. It the They were silent when DISK banned. They did not raised any protest when 52 leaders of DISK put into trails. They even did not defend the banned TURK-Is unions. They gave their general secretary to the anti-vorker government.

They remain silent for more than two years against the restricted union activity. They subjugated to the practices of High Arbitration Council and even gave where representatives to this council.

During the stages of preparation, discussion and finalisation of the draft constitution, TURK-IS administration trampled over the Congress resolutions of TURK-IS. They did not put the resolutions in order to defend the 1961 constitution into practice.

They did not perform according to the responsibility ties of the legal working and largest membership.

While the Constitutional commission prepares the draft, TURK-Iş administration and adviced to the workers to wait until Consultative Assembly. While the debates took place in the Consultative Assembly they adviced to the workers to wait the final decision of the junta. When the draft finalized, Executive Committee of TURK-Iş supported this anti-vorker constitution and labeled this as return to democracy.

The chiefs of Turk-Is who mentioned to give the keys of TURK-Is to junta facing this constitution, let the keys aside, gubmitted whole Turk-Is to junta. And welcomed this constitution which forces unions to submit their keys.

I would like to address them once more from this rostrum.

Neither submit your keys, nor make TURK-IS a support to junta! Closely examine your members, your affiliated unions, DISK members, non-organised workers. Learn what can you do in the referandum from your members who write "no to the junta's constitution" on their machines. Learn from the union cammitees! ** leaflets where DISK was organised. Remember ** Turk-Is is a workers' organisation.
