Monsieur le Président,

Nous avons l'honneur de nous adresser à vous pour le motif suivant: afin de pouvoir suivre, à la tribune, les débats sur la 'Situation en Turquie', nous nous sommes rendus, le 24 avril 86 à 14 heures 30 au Palais de l'Europe. On nous a refusé l'accès en disant d'bord qu'il n'y avait plus de place à la tribune.

Une personne, se disant 'réponsable de l'accès au Palais' a également refusé notre demande écrite aux autorités compétentes. Nous lui avons demandé de motiver son refus par écrit, mais nous avons eu un refus de plus.

Il nous a refusé notre souhait de voir un de ses supérieurs. Il a répondu qu'il était son propre chef. Quand nous avons demandé son nom, il a refusé de nous le dire.

Nous lui avons exprimé notre souhait de contacter le Groupe Socialiste que nous avions rencontré dans la matinée. La réponse n'a pas été autre chose que 'non'. Enfin il nous a grossièrement mis à la porte.

Suite à cela, nous avons adressé une protestation énergique, auprès de la Présidence de l'Assemblée Parlementaire du Conseil de l'Europe, tout en demandant d'intervenir immédiatement pour que nous ayons accès à la tribune et précisant que nous attendions devant l'entrée principale du Palais.

Par la présente, nous tenons à porter à votre connaissance, Monsieur le Président, cet état de fait inadmissible et révoltant qui a eu lieu devant une institution internationale qui se veut libre et démocratique.

Dear Sir / Madam ,

Once again you will be discussing the situation in Turkey at the first part of the 37th Session of the Parliamentary Assembly. Your Assembly will once again adopt a resolution on Turkey in the light of the developments there and international norms concerning fundamental rights and freedoms, the European Convention on Human Rights and established principles of the Council of Europe.

We would like to bring to your attention a recently concluded trial in Ankara in the belief that it provides an understanding of the present regime's attitude towards democratic rights and freedoms.

On 29th march 1985, 228 persons were sentenced to 1630 years of prison terms in total by the n° 1 military court of the Ankara martial law command for membership to the Communist Party of Turkey, TKP. They include workers, trade unionists, teachers, students, civil servants, lawyers, writers, journalists, artists and academicians. The sentences range from 4 to 17 years ; they have also been deprived of civil rights indefinitely.

Ankara TKP trial is only one of several TKP trials involving hundreds of defendants. Neither the indictments of the military prosecutors nor the verdicts of the concluded TKP trials could bring any accusation of involvement in violence on the part of the defendants. They have been accused solely for membership to and participating in the activities of the TKP. This accusation however, has been evidenced only by statements extracted from defendants under torture. The Amnesty International has repeatedly pointed to this fact and adopted all defendants in the TKP trials as prisoners of conscience.

The denial of the existence of political prisoners by the Evren-Ozal regime in Turkey has once again been refuted by the verdict made at the conclusion of Ankara TKP trial.

Turkey is the only member of the Council of Europe where a person is prosecuted and sentenced for his/her communist views or membership to the communist party. In fact, she is the only country where communist party is legally banned. The legal basis for this situation has been laid by the well-known articles 141 and 142 of the Turkish Penal Code adopted from the laws in Italy under Mussolini envisaging the "defence of the fascist state". There are no such legislation in other member states of the Council of Europe.

We are certainly aware that the existence of these laws is not confined to post-12th September era and that they have been constituting a major obstacle before democracy in Turkey for nearly 50 years. What is important for the present, however, is this : the harsh sentences given to 228 defendants in Ankara TKP trial is a new exemple of the unscrupulous use of laws incompatible with principles of democracy by the present regime. Indeed, the articles 141 and 142 have been made use of by the martial law courts not only in TKP trials but in many others concerning freedom of thought and expression. As rightly pointed out by the reporter of the legal affairs committee last year, these articles become particularly dangerous when concidered together with the present Contitution.

Furthermore, the conclusion of this trial clearly indicates once again that the present regime has no intention to bring about a general political amnesty and to take steps towards democracy as expressed in the Assembly's resolution adopted last year.

Dear Sir / Madam,

We would like to believe that the above considerations will receive your attention in your assessment of the current political situation in Turkey. We also request your possible initiatives towards securing freedom for defendants of TKP trials sentenced or still on trial only for their political convictions, and for all other political prisoners in Turkey.
